DATUK SERI NORAZLAN APPOINTED AS THE NEW MACC DEPUTY CHIEF COMMISSIONER (PREVENTION)

Datuk Seri Norazlan Mohd Razali has been appointed as the new Deputy Chief Commissioner (Prevention), Malaysian Anti-Corruption Commission (MACC) effective today in conjunction with the mandatory retirement of Dato' Sri Shamshun Baharin Mohd Jamil.

He was the MACC Senior Director of Investigations and previously held the posts of the Director of Agency Integrity Management Division, Director of Selangor State MACC Office, Director of Malaysia Anti-Corruption Academy (MACA), Head Staff of MACC Chief Commissioner Executive Office, Head of Integrity Unit for the Federal Land Development Board (FELDA) and Director of Johor State MACC Office.

Datuk Seri Norazlan, 57, holds a Bachelor of Science in Business Control System, majoring in Accounting from the University of North Texas, United States of America and a Master of Science in Economic Crime Management (Honours) from HELP University, Malaysia.

He began his service with the MACC on 9 February 1989 and during his tenure, accumulated vast experience being actively involved in various corruption prevention initiatives locally and internationally.

Meanwhile, the Senior Director of Special Operations Division, Dato' Hishamuddin Hashim is appointed as the new MACC Senior Director of Investigations effective on the same date while the Head of Integrity Unit, Ministry of Transport, Dato' Tan Kang Sai replaces Dato' Hishamuddin's position.

The MACC has organised a Retirement Ceremony in conjunction with Dato' Sri Shamshun Baharin's retirement at the MACC Headquarters yesterday, adhering to the standard operating procedure (SOP) of the National Recovery Plan.

Dato' Sri Shamshun Baharin's mandatory retirement as a civil servant came at the age of 60 years old, following his commendable service at the Anti-Corruption Agency (ACA) and MACC for 37 years since 1984.

He started his career at the ACA/MACC as an investigation officer and held many important positions during his tenure.

These include the Head of Secret Registration Branch, Director of Planning and Research Division, Director of Integrity Management Division, Director of Record Management and Information Division, Director of Intelligence Division, Director of Community Education Division and subsequently promoted as the MACC Deputy Chief Commissioner (Prevention) on 4 October 2016.



The MACC would like to express gratitude for Dato' Sri Shamshun Baharin's effort and contribution during his tenure at the ACA/MACC to help eradicate corruption in the country.
